Keeping Pace with FSTC Projects: Coach Wayne Miller



1,700 Meals 64 Volunteers 2 Staff

Every month over 1,700 nutritious and delicious meals are served on the Eastern Shore, courtesy of the Meals on Wheels program through the Ecumenical Ministries Inc. or (EMC). EMC is a faith-based, non-denominational social agency providing services in Baldwin County. The Meals on Wheels program is headed by Carol Rupp, who has been Program Director since 2009. Along with an assistant, she plans the meals, helps cook, and oversees sixty-four volunteers. These volunteers include kitchen workers and the drivers who deliver meals on seven routes five days a week.

The purpose of this program is to provide meals to homebound elderly or disabled persons who cannot cook the meals themselves. The charge for each meal is five dollars. If a person cannot afford the meal, Ecumenical Ministries can help subsidize these meals. But another more important part of the program is the daily interaction between volunteer and recipient. For many of the homebound, this brief exchange at the front door might be the only outside contact with someone that entire day.

Currently, the meals are prepared at Fairhope Christian Church while a new building that will house the kitchen is being built. Fairhope Single Tax Corporation has given Ecumenical Ministries matching funds of \$500,000 toward construction of new offices and a commercial kitchen.

Volunteers load up their containers each day starting at 10:30 AM before heading out to deliver. The Tuesday volunteers include Yvonne, Naomi, Elizabeth, Wayne, and Knight. Along with the meal, Carol includes a detailed list with directions and information on each recipient. Josephine Sewell is a long-time volunteer who came to the Meals on Wheels program through the RSVP (Retired Senior Volunteer Program). Jess and Betty Williams are now clients, but over thirty years ago they delivered meals.

Carol reflected on her years of leading with these words: "I am blessed to be able to work with such wonderful volunteers who care about their community. I enjoy my job, especially knowing that we are helping the elderly and disabled receive a good meal and that someone sees them five days a week. The clients are very appreciative, and we have developed close friendships with many of them." Not only Carol is blessed, but the whole community is blessed to have such a passionate and dedicated leader as Carol.
